

TERMS AND CONDITIONS FOR PARTICIPATING IN THE FIRSTSTARS REALITY SHOW

Please read these terms and conditions carefully. By entering this competition, you will be deemed to have read them and will be legally bound by the terms and conditions.

1. Competition Eligibility

To enter this competition, you must:

- (a) Be 18 years or above at the time of entry,
 - (b) Have an acceptable form of identification. (Examples of such includes but is not limited to, a Driver's license and International Passport)
